

## DEFENSE RELEASE, INDEMNITY AND HOLD HARMLESS AGREEMENT

As provided in Ordinance 4374 of the City of Liberal Municipal Code, any person operating a golf cart on designated City streets does so at their own risk and must operate such vehicle with due regard for the safety and convenience of other motor vehicles, bicyclists, and pedestrians.

The undersigned golf cart owner (the "Owner") hereby agrees to indemnify, defend, and hold the City of Liberal (the "City"), its officers, agents, servants, and employees completely harmless from and against any and all liabilities, losses, suits, claims, judgements, fines or demands arising by reason of injury or death of any person or damage to any property, including all reasonable costs of investigation and defense thereof (including, but not limited to, attorney fees, court costs, and expert fees), of any nature whatsoever arising out of or incident to the acts or omissions of the Owner, its agents, employees, contractors, subcontractors, subleases, licensees, invitees, or of any third person in the use of the Owner's golf cart, regardless of where the injury, death, or damage may occur except for claims, losses, or damages arising solely out of the actions or inactions of the City. The liability of the City, as set forth in this paragraph, is intended to be consistent with limitations of state law, including the state's waiver of sovereign immunity, and no obligation imposed hereby shall be deemed to alter said waiver or to extend the liability of the City beyond such limits:
