Effective September 1, 2025

The fine amounts indicated below do not include court costs. Court costs for traffic offenses are \$80.00 unless otherwise stated. Court costs for parking offenses are \$10.00. All parking offenses are marked "Parking:". If charged with more than one offense, only the higher court cost will be charged to the defendant. The fine is doubled for all traffic infractions, including speeding, when the infraction is in a school zone or construction zone. Anything marked "COURT" requires a court appearance.
